# ARTICLE 5 TERMINATION

#### **5.**1 Termination for **Concessionaire's Event** of Default:

- 5.1.1 Without prejudice to any other rights or remedies which UPMRC may have under this Agreement, upon occurrence of a Concessionaire's Event of Default as defined in article 10.2 of DLA, UPMRC shall be entitled to terminate this Agreement; provided that before such Termination, UPMRC shall by a notice of default, inform the Concessionaire of its intent to terminate the Agreement and grant 30 (thirty) days to the Concessionaire to cure the default, and may after expiry of such 30 (thirty) days, terminate the Agreement.
- 5.1.2 Where the Agreement is terminated by UPMRC upon Concessionaire's Event of Default, UPMRC shall have the right to forfeit the entire Interest Free Security Deposit and the Concessionaire shall have no claims against UPMRC. UPMRC shall also have the right to recover any amount due from concessionaire which UPMRC is not able to adjust from the IFSD submitted by the concessionaire in the present agreement/contract from any other contract of the concessionaire with UPMRC or otherwise.

# 5.2 Termination by UPMRC for Convenience:

- 5.2.1 UPMRC may, at its sole discretion, for any reason whatsoever, at any time during the Concession Term after the expiry of lock-in period as per clause no. 24 of chapter (V) of RFP, terminate the rights of the Concessionaire with respect to any of the Licensed space(s) or all the Licensed spaces, whenever UPMRC shall determine that such Termination is in the best interests of UPMRC; provided that before such Termination, UPMRC shall give a notice of 180 days' and inform the Concessionaire of its intent to terminate the Agreement.
- 5.2.2 The Concessionaire agrees and acknowledges that, upon Termination by UPMRC for convenience, the Concessionaire shall not be entitled for damages, reimbursement of any costs or compensation for anticipatory profits.
- 5.2.3 Where the Agreement is terminated by UPMRC for convenience, on expiry of notice period and payment of all outstanding dues and after vacation of the licensed spaces and restoring it to its original state, UPMRC shall release and refund the available Interest Free Security Deposit to the Concessionaire.


