3. NOTICE INVITING TENDER

- 3.1 Uttar Pradesh Metro Rail Corporation Ltd. (UPMRC) has successfully commenced its services on entire North-South Corridor from CCS Airport to Munshipulia consisting of 21 Nos. Metro Stations with total stretch length of 23 km from 9thMarch 2019 in Lucknow. Lucknow Metro has carried over 7.6 crore commuters till date, which is almost 13 times more than actual population of Lucknow. The Lucknow Metro is most popular skyliner that zaps through the city giving a view of the high rise buildings, parks and other places above the typically hectic streetscape, with entrances at both sides of the road, but more importantly connecting end to end urban setup in the shortest possible time. It is one of the finest examples of mass transit system with its world class infrastructure and state of the art technology making it 'Lucknow's Pride'.
- 3.2 In order to fulfil its mandate to raise non-fare revenue, UPMRC invites open e-tenders on two packet system from interested parties which may be a sole proprietorship firm, a partnership firm or a company having registered office in India and incorporated under the company act 1956/2013, or a combination of above in the form of Joint Venture(JV) or consortium for selection of licensee for granting the license for 'Licensing of space on pillars N-S Corridor of Uttar Pradesh Metro Rail Network in Lucknow for placement and operation of telecom equipment for Providing Shared Mobile (Cellular) Coverage upto 5G'. UPMRC shall receive E-Bids pursuant to this RFP document, in accordance with the terms set forth herein as modified, altered, amended and clarified from time to time by UPMRC.
- **3.3** Bidders shall submit Tender/bids in accordance with such terms and conditions on or before the date specified in this document. Bidders are advised to visit the UPMRC premises at the respective station / site and familiarise themselves with various arrangements and all activities necessary in this regard.

- The Bid security amount shall also be submitted in the form of Demand Draft (DD) drawn on any Indian Scheduled Bank in favor of "Uttar Pradesh Metro Rail Corporation Limited" payable at Lucknow.
- The Bid shall be summarily rejected if it is not accompanied with valid bid security of appropriate amount.
- The bid security/EMD in original physical form must invariably be submitted to UPMRC by the stipulated time frame as given in clause 3.4 of NIT, failing which the bid is likely to be rejected.
- The bid security of the Selected Bidder shall be adjusted against the Interest Free Security Deposit (IFSD). The bid security (submitted towards the bid/tender) of unsuccessful bidders/tenderers, shall be refunded within 90 days after award of contract, without considering any interest, thereof. If the bidder

withdraws its bid at any stage, UPMRC shall have the right to forfeit the bid security amount of the bidder.

3.6 Eligible Applicants:

Tenders for this contract will be considered only from those tenderers (proprietorship firms, partnerships firms, companies, corporations,) who meet requisite eligibility criteria prescribed in the Clause 3.7 below. In the case of a JV or Consortium, all members of the Group shall be jointly and severally liable for the performance of whole contract.

- 3.6.1 A tenderer shall submit only one bid in the same tendering process, either individually as a tenderer or as a partner of a JV/Consortium. A tenderer who submits or participates in more than one bid will cause all of the proposals in which the tenderer has participated to be disqualified. No tenderer can be a subcontractor while submitting a bid individually or as a partner of a JV/Consortium in the same bidding process
- 3.6.2 Tenderers shall not have a conflict of interest. All Tenderers found to have a conflict of interest shall be disqualified. Tenderers shall be considered to have a conflict of interest with one or more parties in this bidding process, if: participation by a bidding firm or any of its affiliates that are either involved in the consultancy contract to which this procurement is linked; or if they are part of more than one bid in the procurement; or if the bidding firm or their personnel have relationships or financial or business transactions with any official of procuring entity who are directly or indirectly related to tender or execution process of contract; or improper use of information obtained by the (prospective) bidder from the procuring entity with an intent to gain unfair advantage in the procurement process or for personal gain.
- **3.6.3** The Tenderer/applicant (applies to each individual member in case of a Joint Venture/Consortium) must not have been blacklisted or debarred or convicted as on the due date of submission of bid by Government of India/ State Government / C.C.I / Government undertaking. The tenderer shall submit a "Verification Statement" to this effect as per proforma placed at Annexure 9.
- 3.6.4 A firm, who has purchased the tender document in their name, can submit the tender either as individual firm or in Joint Venture/Consortium.

3.6.5 If a Bid is submitted by a JV/Consortium, following shall be abide by its members:

- i. The Lead Member of the JV/Consortium shall maintain a minimum percentage share of 51% of the aggregate shareholding of the JV/Consortium during full tenure of License Agreement.
- ii. Minimum percentage stake of any member in JV/Consortium during license period (including lock-in period) shall not be less than 20%.
- iii. Any change in percentage stake of JV/Consortium members without prior written approval of UPMRC shall be treated as Material Breach of Contract and Licensee's Event of Default entitling UPMRC to encash Interest Free Security Deposit and/or to terminate the License Agreement after 30 days' notice.
- iv. All members of such entity shall be jointly and severely liable for the performance of License agreement.
- 3.6.6 The Tender Document submitted without the cost of bid document and/or bid security/EMD amount in specified form and validity, shall be out rightly rejected.
- 3.7 Eligibility Criteria: -
- 3.7.1 <u>Average Annual Turnover</u> of the bidders during the last three year ending 31st March of the previous financial year should be at least 23 <u>Lakhs</u>. The Bidder shall submit audited financial year data of last three years (i.e. FY 2020-21, 2021-22 and 2022-23) certified by Chartered Accountant with stamp & signature along with UDIN.
 - * In case audited Balance sheet of the last financial year is not made available by the bidder, they have to submit an affidavit certifying that the balance sheet has actually not been audited so far, in such a case financial data of previous 2 years will be taken into consideration for evaluation.
 - In case of JV/Consortium, full value of the work, if done by the same joint venture shall be considered. However, if the qualifying work(s) were done by them in JV/Consortium having different constituents, then the value of work as per their percentage participation in such JV/Consortium shall be considered.
 - The average annual turnover of JV will be based on percentage participation of each member. *Example:* Let Member-1 has percentage participation = M and Member - 2 has =N. Let the average annual turnover of Member-1 is 'A' and that of Member-2 is 'B', then the average annual turnover of JV will be

- 3.7.2 The Bidder must have Access Service License/ IP Registration Certificate issued from Department of Telecom Govt of India. The bidder shall encase a copy of Access Service License/ IP Registration Certificate issued from Department of Telecom along with its Bid.
- 3.8 Brief scope of work is mentioned as below:-
 - **679 no. pillars** are available along the central median of the elevated section (excluding pillars under station boxes) of N-S corridor of UPMRC network at Lucknow for the installation of telecom equipment for providing shared mobile (cellular) coverage upto 5G.
- 3.9 License period shall be for a period of Three (03) years from commencement of license fee.
- 3.10 The license may be extended by two periods of three (03) years each on successful completion, to the complete satisfaction of UPMRC, of initial Three (03) years on mutually agreeable terms & conditions.
- 3.11 The intending tenderers must be registered on e-tendering portal https://etenders.gov.in/eprocure/app
 .Those who are not registered on the e-tendering portal shall be required to get registered beforehand.
 After registration, the tenderer will get user id and password. On login, tenderer can participate in tendering process and can witness various activities of the process.
- 3.12 The authorized signatory of intending tenderer, as per Power of Attorney (POA), must have valid

Class-II or Class-III digital signature. The Bid document/RFP can only be downloaded or uploaded using Class-II or Class-III digital signature. However, the tenderer shall upload their tender on https://etenders.gov.in/eprocure/app using class-II or class-III digital signature of the authorized signatory only.

- 3.13 Tender submissions shall be done online on https://etenders.gov.in/eprocure/app after uploading the mandatory scanned documents towards cost of tender documents and bid security such as scanned copies of transaction of payment i.e. RTGS, NEFT & IMPS or DD/Bank Guarantee submitted against the bid security amount and other documents as stated in the tender document. Instructions for on-line bid submission are furnished hereinafter.
- 3.14 Submission of Tenders shall be closed on e-tendering website of employer at the date & time of submission prescribed in NIT after which no tender shall be accepted. It shall be the responsibility of the tenderer to ensure that his tender is submitted online on e-tendering website https://etenders.gov.in/eprocure/app before the deadline of submission. The Employer shall not be responsible for any delay, difficulties and/or inaccessibility of the downloading and/or uploading facility from the e-procurement portal for any reason whatsoever.
- 3.15 UPMRC reserves the right to accept or reject any or all proposals without assigning any reasons. No tenderer shall have any cause of action or claim against the UPMRC for rejection of his proposal.
- 3.16 Tenderers are requested to visit e-tendering portal https://etenders.gov.in/eprocure/app regularly for any Employer's issued clarifications, addendum, corrigendum and/or due date extensions.
- 3.17 After successful completion of tender processing, the Letter of Acceptance to the successful bidder shall be uploaded on the e-tendering portal https://etenders.gov.in/eprocure/app which can be downloaded by successful bidder. LOA would also be E-mailed to the successful bidder.
- 3.18 In case at a subsequent date the successful bidder/licensee is found to have been banned for business as given above, UPMRC shall be at liberty to and have full right to cancel the allotment space on pillars of N-S Corridor of Uttar Pradesh Metro Rail Network in Lucknow for placement and operation of telecom equipment for Providing Shared Mobile (Cellular) Coverage upto 5G and forfeit the interest free security deposit after adjusting any dues payable by the licensee.
